CONDITIONS:

- A. The standard SPI Preventative Maintenance Service is expanded for the California Institute of Technology ESCA System. During the Preventative Maintenance visit SPI will perform the service listed on the standard schedule. In addition we will:
 - Change the oil on all system turbo pumps and mechanical pumps.
 - 2. Make adjustment to all system sample transfer, sample positioning and sample holder mechanism.
- B. During the emergency service SPI will repair any part of the system except the LEED instrument. SPI standard rules apply to the emergency service. Repair parts will be taken out of MAA.
